

PRESS STATEMENT

Asian Sepaktakraw Federation (ASTAF) Media Statement on the election of the New President of ASTAF, Abdul Halim Kader from Singapore for the term 2021 to 2025.

The ASTAF Congress Election was conducted successfully on 1 March 2021 through Zoom due to the Covid19 pandemic. Incumbent President Abdul Halim Kader secured a landslide 30 votes from representative members with his 2 challengers Dato Seri Ahmad Ismail, President of Malaysia Sepaktakraw Federation (PSM) and Mr Mohd Nasri Haron, President of Singapore Sepaktakraw Federation (PERSES); both failed to secure any votes from the participating country members.

This is the first time that Abdul Halim Kader was facing a contest for the President's position since he helmed ASTAF since 2004. Notwithstanding the contest by the two challengers, his popularity amongst the ASTAF member countries remains strong resulting in the resounding victory, a testament to his dedication and his passion for Sepaktakraw.

Abdul Halim Kader was nonchalant about the contest and preferred to remain focused with his ongoing passion to promote Sepaktakraw and expand membership further to include other Asian countries. To date after 17 years as President of ASTAF, Abdul Halim Kader and his team managed to infuse into the federation, 18 new member countries (7 countries as full members of ASTAF from Middle East to East Asia including Macau, Chinese Taipei and Hong Kong. As to date, ASTAF has 25 full members and Abdul Halim Kader and his team will be targeting to expand further to include 10 new Asian countries which will accumulate to a total of 35 playing countries in Asia.

Abdul Halim Kader and his team are also working actively to bring Sepaktakraw to be a recognised Sport with the International Olympic Committee (IOC).

Abdul Halim Kader and his team are confident to achieve this during the next ASTAF term for 2021 to 2025. To this end, Abdul Halim Kader team's most significant achievement was to gain acceptance of Sepaktakraw by IOC TV channel together with five other international sports. Abdul Halim Kader and his team's dedication and commitment to Sepaktakraw has achieved its epiphany in gaining recognition for Sepaktakraw by Olympic Council of Asia (OCA) and ASTAF will and must continue to work closely with OCA.

General Charouck himself a firm practitioner in this tradition grooming the next generation of leaders to expand ASTAF further. Abdul Halim Kader remains indebted and humbled by this trust. He is confident to receive the strong support from ASTAF member countries as he leads the new Council and work with the new team to grow ASTAF and expand its reach with a stronger and dynamic team to make Sepaktakraw a recognised sport across Asia.

SPEECH BY ABDUL HALIM KADER AT OPENING OF ANNUAL GENERAL MEETING OF ASTAF CONGRESS ON 1 MARCH 2021 AT 4 PM VIA ZOOM APP

Let me first welcome all delegates to this ASTAF Congress 2021 in which for the first time we are using an electronic platform.

This AGM is called very late in the day because of the Covid 19 epidemic that has plagued the entire world. Each country has been implementing its own standards in dealing with Covid. As the world had come to a complete stand still during the height of Covid, it is now necessary to restart our lives in a manner safe for all to participate.

As you are aware, we hold our Congress and elections once every 4 years from 2004, 2008, 2012 and 2016. Adequate notice of one month has been provided all this while and all members have adhered to it. We have been very open and transparent in our dealings with members and members with issues have been able to approach ASTAF directly or through the Council and the Exco. We have had no issue and in fact all members have shown their appreciation for efforts that ASTAF has put up.

In light of the above, the Registrar of Societies has advised that AGMs can be held by way of electronic means. We have certain shortcomings with respect to how this can be managed given the limitations of the electronic platform and ASTAF has therefore put in certain guidelines to facilitate the Annual General Meeting. So that the meeting may progress, the Chair and EXCO will lead the meeting and introduce the various agenda items.

I have decided to appoint Mr Boonchai Lorhpipat, Secretary General ASTAF who is not contesting in this Congress, to chair these proceedings of Congress. This is provided for in the Constitution for the me as President to do so.

Without further delay I hand over the chair to Mr Boonchai Lorhpipat- please welcome him.
